



# Pre-Trial Prisoner Requirements Checklist for Yokosuka PCF

Disclaimer: Failure to bring all required items will result in the refusal of confinement.

## **REQUIRED ITEMS:**

- ☐ Confinement Order (DD FORM 2707, REV NOV 2022) original signed form.
  - Medical confinement physical has to be signed within 24 hours of confinement.
  - For an Enlisted Pre-Trial Prisoners any Commissioned Officer could sign the confinement order.
  - For an Officer Pre-Trial Prisoners, it has to be their Commanding Officer to sign the confinement order.
- ☐ Military ID (CAC Card).

  ☐ Medical and Dental records (if the Pre-Trial Prisoner's command is out to sea during check-in and is unable to obtain medical and dental records, the command has 48 hours from pulling back into port to bring the records to the Pre-Trial Confinement Facility).

  ☐ Money Cash \$50.

☐ Prepaid Phone Card Maximum Value of \$50 (Prepaid Phone Cards could be purchased at the Fleet Recreation Center on the second floor at FADTECH).
