RMKS/1. This message contains all off-limits actions taken in
accordance with reference (a) and includes all establishments
currently off limits.
2. In accordance with references (a) and (b), an installation
commander has the authority to place an area or establishment off
limits if it is determined to be harmful to the welfare and safety
of Armed Forces personnel and their dependents.
3. Pursuant to reference (b), service members who visit off-limits
establishments may be punished under Article 92, UCMJ, failure to
obey a lawful general order. The names and locations of the
establishments currently off limits in Japan are as follows:
a. Empire Lounge Bar, Saito Bldg. 5F, 3-13-8, Roppongi Minato-ku,
Tokyo, Japan
b. Vibrations Bar: 3 Chome-11-6 Roppongi, Minato, Tokyo, Japan

c. Mona's Bar: 2-20 Honcho, Yokosuka, Kanagawa 238-0041

d. Night Club: Kanashiro Bldg 2F, 1-14 Kabuki-cho, Shinjuku-ward, Tokyo, Japan

e. Sasha Latin Resto Bar: 1 Chome-10 Honcho, Yokosuka City, Kanagawa, Yokosuka, Japan.

f. Yoshihara Red Light District: In the Yoshihara Red Light District, establishments with a storefront that faces 329 or 330 are not off-limits.

g. Yasu Ichi Bookstore: 2-1-10 Chatan, Okinawa, Japan

h. "Soap Land:" Area 2, Tsuji District, Naha City is a 3x4 block area within Area 2 consisting of 56 bathhouses. Western boundary of Soap Land is Gas Dori Street and Salada Bowling Alley. Northern boundary is Route 47. Eastern boundary is Route 43. Southern Boundary begins at Gas and 127.668 longitude and ends at Route 43 and 127.671.

i. Takahara Hotel: adjacent to the Nakagusuku Castle in Ishado, Nakagusuku Village, Okinawa, Japan

j. Ground Tobacco Shop: 2F 1-5-9 Mihama, Chatan Cho, Okinawa, Japan

k. Club Epica: 1 Chome-5-1 Naha, Matsuyama, Okinawa 900-0032

l. Club Harvel: 2 Chome-13-14 Kumoji, Naha, Okinawa 900-0015

m. Bullseye: 4-16 Kitame, Chatan, Okinawa, Japan

n. Tokyo Bookstore Chatan Shop: 904-0101 Okinawa, Nakagami District, 820-6

p. BuriBuri NomiB: 1-18 Horikawa- cho, Naka-ku, Hiroshima City, Japan

q. Joint: 3-22 Yayoi i-cho, Naka-ku, Hiroshima City, Japan

r. Spice Ecstasy: 4-4 Nagarekawa, Naka-ku, Hiroshima City, Japan

4. The area that follows is currently off limits in Singapore.

Additionally, servicemembers who visit this area may be punished under Article 134, UCMJ, for patronizing a prostitute. The area currently off limits is part of a designated red light area (DRLA) where prostitution is legalized in Singapore:

a. The Geylang DRLA, located at the even numbered roads from Lorong 2 Geylang to Lorong 40 Geylang, Singapore.

5. This order applies to all Navy service members located and operating in Japan, including Okinawa, and Singapore, who are subject to COMUSINDOPACOM authority, including reserve personnel (when serving in a reserve capacity), National Guard personnel when in an active or drilling status, and personnel in a TAD/TDY, deployed, leave, or pass status. This order also applies to members of other branches of the Armed Forces attached to a Navy unit or located onboard a naval installation in Japan. This order's application includes permanent party, expeditionary, and rotational units.

6. Commands are encouraged to publish this order in their plan of the week or by other means to ensure widest dissemination.
